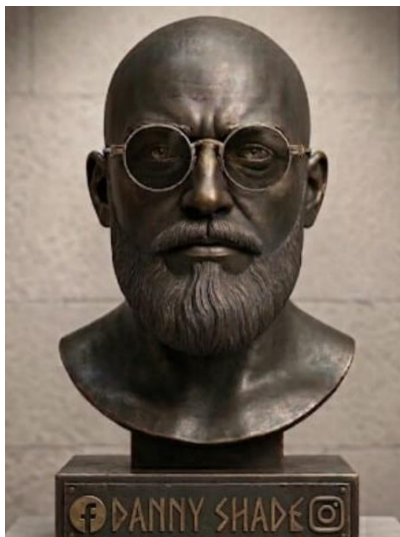

DESCRIPTION OF RISKS
